# Message from the Board

This year, as Young Lungs Dance Exchange celebrated its 20th anniversary, we found ourselves reflecting not only on two decades of programming, but on the spirit of collaboration and curiosity that has carried this organization from its very first gathering to where it stands today. The 2024/2025 season reminded us how meaningful it is when artists support one another, and how deeply we value the community that continues to grow and shape this work.

We are incredibly proud of the publication created for our anniversary year, a beautifully crafted 175 page book that honours and archives the artists, initiatives, and ideas that have shaped YLDE. Seeing participants connect, challenge themselves, and celebrate each other was a highlight of the season.

Our 20th Anniversary Festival embodied the heart of YLDE: artists boldly experimenting, audiences gathering together, and a dedicated team working to make space for both. We are grateful to curators Aria Evans, Luther Konadu, and Charlene van Buekenhout for shaping a festival that celebrated range, risk, and imagination, with a special thank you to former Director Zorya Arrow for selecting the twenty artists two years ago.

And we extend heartfelt thanks to our diligent production team, including Production Manager Tanner Manson, for bringing so many moving parts together with care and professionalism.

We were delighted to continue our work with Marketing Director Erica Urías, whose collaboration with Executive Director Alex Elliott and Programming Manager Gaby Ortiz strengthened the clarity, intent, and reach of our communications.

Across every program and event this season, we continued our commitment to accessibility, ensuring ASL interpretation was available and welcoming guests to environments with physical accessibility and gender-inclusive washrooms. We celebrate this as core to our past and future values.

Most of all, we are grateful for our artists, our audiences, our partners, our funders, and the hundreds of community members who have joined YLDE over twenty years. Our mailing list, now over 550 subscribers, reflects a growing community of people invested in dance, movement, and the shared work of supporting and uplifting artists.

As we look to the future, we do so with appreciation for the artists who came before us, pride in the people who lead and support YLDE today, and excitement for the next chapter of this organization's story.

# **Annual Report**

# Introduction


Young Lungs Dance Exchange's 2024-2025 season, and 20th year of engagement, marked a pivotal moment for our organization. We were awarded Operating Funds from the Manitoba Arts Council, we received Charitable Status, as well as project funding from Canada Council for the Arts, Canadian Heritage, and Program Support from the Winnipeg Arts Council. For our 20th Anniversary Season we designed a Publication, hosted a week-long workshop intensive with Alejandro Ronceria, and presented the work of 20 artists over four days. Every event had ASL Interpretation in physically accessible venues with gender inclusive washrooms.

The season began with the hiring of contracted Marketing Director Erica Urías who worked closely with graphic designer David Oro, Executive Director Alex Elliott, and Programming Manager Gaby Ortiz. We also continued working with Torrin Swanson from Collective Technologies for tech support, and Lesage Accounting for Bookkeeping and Accounting.

# **Programming**

# 1) 20th Anniversary Publication

Executive Director Alex Elliott worked closely with Designer David Oro to create this 175 page book that holds the first twelve years of productions followed by eight years of residencies, alongside visual and written essays. What follows is an excerpt from the book, messages from the founders, who reminded me later that yes they created and produced the first show, but the continuous contributions from hundreds of artists along the way is at the heart of Young Lungs Dance Exchange.







At the time, we were pretty fresh out of a training program and entering into a professional landscape in Winnipeg where opportunities were limited. As young artists this environment was pushing us to be pinned against each other. Putting together our first show, Not Frozen or Canned, was an active move towards shifting this competitive environment into a collaborative one.

Not Frozen or Canned proved that supporting each other, turned a daunting challenge of self-production into what felt like a party. So why not make it a shaker! Opening the door in future productions to whoever wanted to present work, also meant celebrating that diversity of voices inevitably contributes to the growth and development of art forms and supports everyone's evolution.

These first experiences also underlined how our collaborative and cooperative approach created the needed safety net to take chances and experiment with our art practices, a true communal trust in the process of learning and growing. I am so grateful for our young, rebellious, visionary selves.

Through Young Lungs I was able to build my confidence and abilities in areas such as performing, teaching, choreographing, and producing which has helped me to have a vast and vibrant 20 year career in dance. 

Young Lungs has supported my growth in a number of ways throughout the development of my career. Through collectively organizing the show "Not Frozen or Canned" in 2004/05 among a few other Young Lungs one-off events that year, I learned about communication and collaboration. It was a steep learning curve for me, as it was my first year out of my BA honors in dance. Prior to this show with Young Lungs, I had done performances primarily in bars and informal venues as part of work with the band Absent Sound and performance collaborator Brian Longfield. The conventions of producing work in a theatre brought many new learning curves which I learned alongside peers involved in the "Not Frozen or Canned" Young Lungs production. At that time peer support was vital in supporting me as an emerging artist, the process validated that we could actualize projects without being an organization with ongoing funding. Subsequently, in 2016 Young Lungs supported early research of my work CPA [Consistent Partial Attention], the project was a pivot point for my work with technology and integrating additional performers / collaborators and the time for research and feedback was excellent during a vital transition point in my body of work. The landscape of dance in Winnipeg has changed over the last 20 years and independent production has been necessary to sustain the community. Young Lungs has continued to cultivate platforms for artists of all kinds that relate to movement and performance, to foster creation and production, artist talks and workshops, as well as commission written responses to work. The organization continues to bridge career development for artists across genres broadening the community of folks invested in live art. Looking forward to the next 20 years Young Lungs!

# 3) Workshop

We hosted award winning teacher Alejandro Ronceria, former Director of Dance Training at Banff Centre for Arts and Creativity, in partnership with The School of Contemporary Dancers, over Spring Break in April 2025. We had our highest participation with over 15 registered participants attending this week-long intensive titled, Workshop for Dancers, Performers and Choreographer. "This workshop allows emerging to established dancers, performers, and choreographers focused on conception and development to gain creative and performing tools and learn to use space, time, dimension, musicality, and narrative elements. The participants engage in movements and exercises to discover their relationship with space, sound and the physical environment."





# 4) 20th Anniversary Festival

We undertook an ambitious project and it was an absolute success. We had originally planned to have a symposium as part of our 20th Anniversary programming, which included workshops, talks, and performances, but after speaking with all 20 artists who were selected, everyone wanted a work presented. We presented original work by 20 artists, local, national, and international, and hosted 59 performers at le Centre Culturel Franco Manitobain. We flew 11 artists into Winnipeg.

Due to the multidisciplinary nature of our organization and the foundation it was built on, all four festival dates showcased a wide variety of live performance, always grounded in the body. YLDE's artists have always existed on the fringe and the entire community was in awe at the audience turnout.

Our organization has been consistently enriched by the staff and board members throughout its twenty year history. Because of this, our mission, mandate, vision, guiding principles, and five year strategic plan gave us crystal clear guidance and support throughout Festival planning.
